What is Community Wellbeing



Wellbeing is an increasingly common term that can describe wider conditions than good physical and mental health, which we need as individuals and communities to have a better quality of life, a healthier environment and increased prosperity. Some of these are things that we can easily measure, like the number of school places, or the speed with which an ambulance can get to a sick person. Others are less easily measured, such as our pride of place, our heritage and the way in which we all look after each other. All aspects of wellbeing are connected to each other. So, for example, if our natural environment is poor, it will affect our mental and physical health as well as our economy. In other words, all the parts of our community wellbeing are interconnected. That said, one thing everyone agreed on is that we would like our community to be the very best it can be.

Although we often think about wellbeing in terms of good physical and mental health, it can also describe the wider conditions we need as individuals and communities to have a better quality of life, healthier environment and increased prosperity.

Considering all the aspects of community wellbeing together helps us to identify actions that can be undertaken by communities alongside local and national governments.

During workshops & consultations with WPPN Community Groups Community Wellbeing was considered and assessed under 6 Headings (**aligned to The Sustainable Development Goals SDG – see over**)



Social & Community Development - How can we be an inclusive community where we support each other and ensure no one is left out? What are the important social services and facilities we need to live well from childhood to old age?

Environment & Sustainability - How do we value our natural environment and man-made heritage? What can be done to conserve, protect and restore these? How can we interact with the environment in a sustainable way, and hand it on to the next generation in a better state?

Work, Economy & Resources - How can our communities thrive economically, with good jobs, and supports for enterprise, business and for people not in work? What resources do we have and are they used effectively and sustainably without causing harm to social and environmental sustainability?

Health - How can all members of our community enjoy the best possible physical and mental health? What about people with special needs, older people, and carers?

Values, Culture & Meaning - What is needed to ensure that everyone both feels, and actually is, included and valued, and that our different values and cultures are respected and nurtured? What are the important parts of our culture that we want to hand on to future generations?

Participation, Democracy & Good Governance - What is necessary to ensure that our local government structures support the wellbeing of our community for this and future generations? What is necessary to ensure that we have a voice in the decisions that affect us and that all voices are being heard?

The Sustainable Development Goals (SDGs)



The Sustainable Development Goals are the blueprint to achieve a better and more sustainable future for all. They address the global challenges we face, including those related to poverty, inequality, climate, environmental degradation, prosperity, and peace and justice.

In September 2015, Ireland was one of the 193 Members States of the United Nations (UN) who adopted these goals. The Goals interconnect and in order to leave no one behind, it is important that we achieve each Goal and target by 2030.

Governments have primary responsibility for implementing the SDGs, but the Goals do not belong solely to governments. The Goals belong to everyone, in every community, in every country across the world. To achieve the SDGs, governments, businesses, communities and individuals will all have to work together. Everyone can contribute to that work, from businesses adopting sustainable corporate strategies, to communities working together to improve their local environment, to the individual choices we all make as consumers.

For this reason Westmeath PPN have identified how Our Vision links with the shared goals and have identified for each wellbeing “domain” or aspect which Sustainable Development Goal is being progressed with the vision. A summary of this overlay is shown overleaf.

Workshop

PPN Members were invited to attend Community Wellbeing workshops.

At these workshops the Community Wellbeing concept was presented.



2

Asset Mapping

Working in groups, attendees then highlighted the “assets” and aspects of their community that they wish to preserve and protect for current and future generations.



3

Wellbeing vision

Using the 6 Community Wellbeing headings, attendees shared what they (and the organisations they work for) considered to be important for their community's wellbeing.



4

Consultation

Following the workshop, an online consultation was shared with members who were unable to attend the workshops.

They were provided the opportunity to answer the same questions asked at the workshop.



5

Draft Vision

The PPN resource workers and secretariat members then analysed the responses from the workshop and online consultation.

They then produced the draft wellbeing statements.

These were developed by reviewing and analysing the responses from the workshops and consultation; then distilled/translated these into “high-level” statements.

Athlone Municipal District Vision for Community Wellbeing



Overall Athlone Municipal District Vision

Athlone Municipal District has a flourishing community and thriving economy where we live and work sustainably in a rich environment. It is a safe place where each of us has the freedom to live the lives we choose and respects the diversity within our community. Everyone participates actively in our society and no-one is left behind.

Values, Culture and Meaning

In Athlone Municipal District we recognise, protect and actively enjoy our unique natural assets and built heritage. We celebrate our Irish culture, heritage and traditions while welcoming and respecting other cultures in our community.

- We value our unique Irish and local heritage, preserve this and pass all aspects of it on to future generations.
- All our citizens are supported to access and enjoy our natural environment and amenities.
- We actively participate in an outdoor and sporting culture.

Work, Economy and Resources

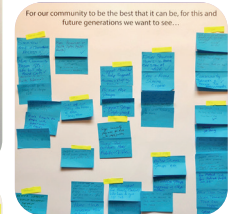
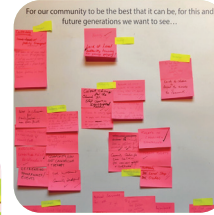
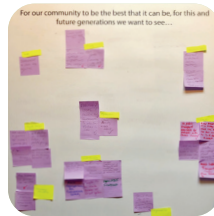

Westmeath Public Participation Network (PPN) is an independent network of not-for-profit volunteer-led groups spread across County Westmeath. Groups include community & voluntary, environmental, and social inclusion groups active within the county.

Westmeath PPN is run by a volunteer committee, the Secretariat, elected by the membership whose responsibility is to oversee the development of the network. Westmeath PPN has one full-time member of staff- the PPN Resource Worker (RW), who assists the Secretariat in the day-to-day running of the PPN and in its development.



There are three main objectives for PPNs:

Informing

Provide information relevant to the environmental, social inclusion, community and voluntary sector and acts as a hub around which information is distributed and received.

Developing

Strengthen the capacity of communities and of the environmental, social inclusion, community & voluntary groups to contribute positively to the community in which they reside/participate.

Representing

Facilitate the participation and representation of communities in a fair, equitable and transparent manner through the environmental, social inclusion, community and voluntary sectors on decision making bodies.

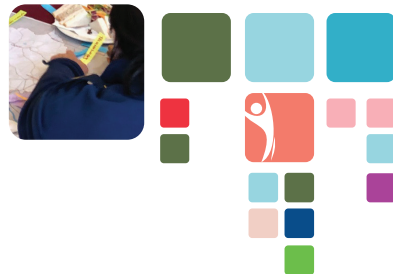
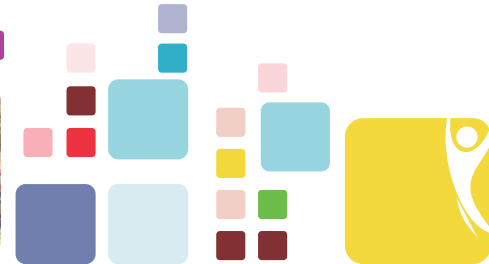
